#### **Description:**

- This is an opportunity to work in a German-based asset management company with an AUM of \$300+ mn, which invests across most asset classes and sectors globally.
- The role involves working in collaboration with a Team of Equity Analysts to support all aspects of the management of equity portfolios.
- Preparing and updating screeners, financial modelling, forecasting, sector databases, finding themes and trends across sectors and working on initial-level investment notes.
- Liaising with internal stakeholders, Senior Analysts and the Portfolio Manager, maintaining clear communication of work, and willingness to take on additional tasks.

## **Responsibilities:**

- Tracking dedicates sub-sectors and stocks assigned by senior analyst, updating the Equity Research Team and the Portfolio Manager with news and events.
- Supporting the analysts on various tasks, varying from data gathering, populating data in financial models, preparing sections of reports, and deep-dive secondary research to populate industry/company presentations.
- Building and updating industry domain knowledge about portfolio companies Industry Analysis.
- Prepare initial research reports on different stocks.
- Attend conference calls and write quarterly reports.
- Maintaining a task list of ongoing/pending tasks regularly, and finalizing task priorities with the analysts
- Regularly communicating with the Equity Research Team and the Portfolio Manager on project updates and being up-to-date with (sub-)sector happenings
- Build and maintain company and industry models, financial and value screens.
- Monitor the latest news/developments on the underlying stocks in the portfolio and evaluate the impacts on the stocks using qualitative and quantitative methods. Also, monitor macroeconomic news.

- Strong team player and willingness to take on challenges
